10. Matters Relating to Street Furniture/Amenity Provision

(a) Update on Footpaths/Bridleway Projects – Cllr M Peachey is still in contact with SCC regarding recording the Friday Street/Playing Fields route as a public footpath, and the documentation that the landowner will need to sign should be ready soon. SCC are still working on a plan to record the Mildenhall Internal Drainage Board droves and Cllr M Peachey should have an update in the next couple of months. The DMMO applications Cllr M Peachey submitted for West Row (to formally record both current and historic routes) have now gone through the initial assessment and prioritisations. It will probably be a couple of years before we hear anything.

(b) Report on Speed Indicator Device Findings – No increase or reduction in speeds. Pott Hall SID now installed, and data will be produced next month.

- (c) Update on Litter and Waste Bin Relocations The new bin along the path to Mildenhall near to the Staunch has now been installed. Cllr M Peachey will notify WSC so that they can add to their collection schedule.
- (d) Update on Cycle Hoops for Village Shop We now have our licence. Cllr A Fisher will get a quote from Paul Gammon for installation.
- (e) Update on Footpath 30 along river at bottom of The Gravel SCC had their contractors cut the overgrown section of the path west of Gravel House, which has greatly improved the situation, but the eroded parts of the riverbank remain hazardous. They have until August to put forward a plan to repair the bank at which point Cllr M Peachey will take further action.
- (f) Update on repair to Pott Hall Lane It is on the list to be done. Closed.
- (g) Update on Footpath/Streetlighting for Crick Road into Church Road Progress on the proposed new pavement remains slow. Cllr M Peachey will chase SCC Highways.

11. Other Working Party Updates/Reports

- (a) Update on the Quiet Lanes Initiative (Designated Lead Cllr R Hamill) Awaiting installation of poles from SCC.
- (b) Update on Coat of Arms No update. Cllr R Hamill to investigate costings.
- (c) Update on the Article for the Echo to explain the remit of the Parish Council and what services West Suffolk District Council and Suffolk County Council are responsible for. Cllr A Fisher has an updated article which will go into the next edition of the Echo and published onto the Parish Council website.

SCC West Row development – the Environment Agency are making progress on reviewing our information but did not meet the end of May target they originally gave us. No update from SCC who are also awaiting the EA response. Once the EA report has been received, Cllr M Peachey will chase.

Cllr A Fisher reported that D/Cllr D Waldron has given us a grant for £500 for the cycle hoops.

Cllr C Bebee asked if the Parish Council could contribute to the purchase of new football posts for the Village Hall. Cllr R Hamill suggested that the Village Hall contact Community Action Suffolk to see if they could help

Cllr C Bebee advised that the Village Hall who currently maintain the defibrillator, have asked if the Parish Council could take this over and maintain. It was **APPROVED** and **AGREED** that this would not be a problem. Cllr C Bebee will speak to the Village Hall and to Gaynor Fisher who would be able to maintain the defibrillator.

Cllr A Rolfe asked if the Gravel could become a quiet lane. Clerk to ask Cllr M Peachey if he can find out what the status of the road is.
