- (c) Update on Footpath 30 along river at bottom of The Gravel SCC are still trying to avoid doing anything. Cllr M Peachey has sought further legal advice and will have an update next month.

- (d) Update on Footpath for Crick Road into Church Road Progress on the proposed new pavement remains slow. Cllr M Peachey will chase SCC Highways.
- (e) Hedging along footpath running from Ferry Lane to the Church. Clerk to speak to Cllr M Peachey. Defer to next meeting.
- (f) Cllr L Stanbury has requested the installation of Brown Tourist Signs along Cow and Sheep Drove to divert heavy and speeding traffic away from a newly designated Quiet Lane. Currently the lane has a very high volume of traffic because the SAT NAV system directs drivers down Cow and Sheep Drove. This is particularly noticeable on stock car race days when heavy traffic, including vans and lorries with trailers are headed for the Mildenhall Stadium on Crooks Drove.

12. Other Working Party Updates/Reports

- (a) Update on the Quiet Lanes Initiative (Designated Lead Cllr R Hamill) Signs are now up, and Cllr A Fisher will be taking photos on Wednesday 3rd August at 10am.
- (b) Litter picking afternoon has been agreed along Crooks Drove and Cow and Sheep Drove on Wednesday August 24th at 2pm. All interested parties to meet at Mildenhall Speedway. Cllr J Goodenough to speak to Mildenhall Speedway to see if they would be interested in joining the event. Clerk to speak to West Suffolk Police about closing Cow and Sheep Drove for the afternoon. Update next month.
- (c) Update on Coat of Arms No update. Cllr R Hamill to investigate costings.
- (d) Neighbourhood Plan First group planning meeting arranged for Monday 25th July at 7pm in the Church Hall.

19. Chairman and Councillors' Reports/Suggestions (on the night)

The Environmental Agency are still to provide their feedback on the proposed new cemetery site. There has been no further progress on the SCC development plans either.

Cllr A Fisher enquired whether a decision had been made regarding taking over the running of the defibrillator. Clerk to enquire what the progress is from Cllr C Bebee.

Cllr A Rolfe asked if there had been any outcome for his request for the Gravel to be listed as a Quiet Lane. Cllr M Peachey did not think that SCC would list this as a Quiet Lane because it is not a normal road. Currently the public right of way is only on foot. Defer to next month.

Cllr A Goodenough asked about cutting back the overgrowth down the footpath from the Church to Judes Ferry. Cllr A Goodenough also enquired about the cutting of the hedge on the S bend along Beeches Road by Chapel Road. Defer until next month.

Cllr R Hamill said there were still Platinum mugs to be collected. Once the cut-off date has passed, these mugs will be offered to other village children's residents.

The Emergency Plan Policy needs updating in view of recent events due to the heatwave. Cllr A Fisher and Cllr R Hamill will investigate updating the plan with regard to emergency contact numbers and additional information that maybe needed.
