

| C. | D/Cllr Lance Stanbury (West Suffolk District Council) — WSDC is in the process of tax budget setting for the County Council, District Council and Parish Council. Government have granted Councils a good settlement this year above expectations, so most Councils will only be putting up tax against inflation rate. There is an upcoming District Council meeting soon and council tax for Band D will be going up by £12 a year. WSC have plans to reduce costs as much as possible, so it reduces the council tax. WSC has applied for grants from the government to decarbonise as much as possible. At the Council offices car park in Bury, there are plans to build another Hub to link in with Mildenhall Academy. | |
| d. | Sqn Ldr Al Balmer (RAF Mildenhall) - There have been off base road works at the main gate so there has been an increase in traffic at the West Row gate during peak times. Road works have now been completed. Change of uniform policy off base. US service people are now allowed to wear uniform off base. Increased flying now in state of readiness for what is happening at the moment in other parts of the world. Cllr T Gooch-Taylor-Balls raised a question about lane control when leaving the base at West Row. Sqn Ldr Al Balmer said he would mention this again on base. Sqn Ldr Al Balmer is leaving, and a replacement will be in place soon. | |

| | (i) To consider the accuracy and approval of the minutes of the Meeting held on 12th January 2022 were unanimously APPROVED and AGREED (ii) Matters arising not covered by this agenda – Generic banner sited at the junction of Mildenhall Road and Chapel Road, on the grass triangle adjacent to Plantation Farm. For a 2m x 1m the cost is £36.23. The banner slots onto two scaffold poles and made of mesh. Defer until October (iii) To consider the request for Community Woodland and Tree Warden. In July 2020 SCC said they would sort this out. Cllr M Peachey wrote to SCC in December and has since spoken to them again without much luck. Cllr M Peachey has now served a notice to SCC. | d. | Report on recent Speed Indicator Device findings — Mildenhall Road and Hurdle Drove are the worst for speeding. Mildenhall Road speed numbers have come down slightly. Speeding on Hurdle Drove is mainly cars going out of the village towards Beck Row, but only a small handful. The Green and Chapel Road figures are very good and much better. Regarding speeding on Pot Hall Road. The Council put up a black box. The results of the average speed going into Pot Hall Road are 31 MPH, and the average speed going out is 33 MPH which is slightly higher. The volume of traffic per day was 1000 vehicles in either direction. We are getting another SID for Pot Hall Road near Cornflower Road junction and one for the other side of Jude's Ferry Bridge. | |
